BREAKOUT SESSION #1

1 - Missouri Crisis Intervention Team Programs

Officer David Abraham, Independence PD and Dawn Morris, Compass Health Explore how Crisis Intervention Team (CIT) Programs provide a forum for effective interaction between the criminal justice system and mental health care system. CIT Programs are a collaborative community-based approach to recruiting, training, and supporting law enforcement to effectively respond to individuals experiencing a behavioral health crisis. Bringing together behavioral health professionals, law enforcement, hospital systems, emergency departments and community partners, CIT programs focus on de-escalating individuals in crises, connecting them to appropriate behavioral health resources, and diverting them from the criminal justice system.

2 - 21st Century CURES Act/EVV Information and Updates

Terri Woodward will discuss the 21st Century CURES Act as it relates to Electronic Visit Verification. Participants will learn what steps Missouri is taking to meet EVV requirements under the CURES Act, the timeline for its implementation, and what actions providers can take in preparation.

3 - Care Coordination

Maria Miskovic MSW, LCSW, C-ASWCM, Care Choice Care Management In this session, we examine how care coordination can create a more stable environment for patients, families, and providers in outpatient settings or after hospitalization. Although care coordination is used as a fairly generic term in healthcare today, its central responsibility is to meet a patient or client's needs and preferences while ensuring high quality, high value care. Care coordination takes a comprehensive look at the system surrounding a patient, including their medical, financial, spiritual, social, environmental, and legal needs, while factoring the various supports to providing services and care.
